Growth of the health science depends on pooling of evidences from scientific bases. It is essential that the results of the research are shared through wider community. The final stage of research process is submission of articles for publication. Ethical issues are considered to be

important aspects in research and publication as they affect the human health and suffering. The issues concerned to the publication are as follows.

- Authorship: Authorship should be assigned to those persons who have made substantial intellectual contributions to the research and the written paper. The authorship should be decided at the conceptual phase of the research study. Contributions should be clearly described and agreed upon.
- **Multiple publications**: It is unethical for a research paper to be published in more than one journal. It could be wrongly assumed to be multiple study and may be included in meta-analysis leading to inaccurate conclusions.
- **Plagiarism**: Plagiarism is a form of dishonesty in research. It may take the form of "*literal copying*', "*substantial copying*" or paraphrasing. It can also extend from data content to ideas and concepts. Original sources need to be acknowledged.
- Copyright and permission: Permission must be taken to reuse or reprint any material from another journal or textbook or websites or online materials
- Salami publication: Data from a single study are broken up and used to produce multiple papers is

termed as salami publication. The research should ideally be published as a single paper but author may use section of data to create unique papers. This is considered unethical because it can mislead readers believe that the data sets presented are from different sample.

- **Data manipulation**: When the research data are manipulated, fabricated or omitted, the outcomes and conclusions reported in the paper may be scientific but false. This unethical conduct is dangerous, if treatment is proceeded based on the reported findings.
- **Confidentiality**: It is author's responcibility to maintain the confidentiality of patient data identifications in any paper submitted for publication. Permissions are required to use photographs of the patients.
- Data access and retention: The researchers and authors are expected to keep the raw data of their study for certain time period after the paper is published. These should be available for review by the editor and other competent professionals, if deemed necessary.

The research should be planned, conducted, analyzed and published in an honest manner to reach up to the people. Self-restraint and honest is the best method to conduct credible research and publication.

## **Ethics in Nursing Research**



To ensure nursing practice is evidence-based, we need to explore different ways of delivering care and challenge existing systems. We must encourage the process of incorporating proven research results and best practices into everyday practice and encourage continuous

learning. Conducting research is competitive and challenging. Competition helps researchers to produce methodologically sound and credible research that would shape the future of practice. A nurse researcher holds a critical position in the healthcare profession. Nursing research often takes place on the cutting edge of healthcare innovation, with the goal of promoting and improving the health of individuals, families and communities.

Research ethics is fundamental to research practice, nursing education and the development of evidence. In conducting research, it is important to plan for and anticipate any potential or actual risks. To engage in research, nurse researchers need to develop an understanding and knowledge of research ethics and carefully plan how to address ethics within their research. The ethical principles a nurse has to bear in mind in research are analyzed, with respect to patients, society and the profession. Before conducting any study, researchers should consider whether the research is warranted and whether the selection and recruitment of participants is fair. There should be good reason to explore safety practice in research beyond routine evaluation. Furthermore, vulnerable populations should not be differentially exposed to any extra risks brought up by the research without good reason to avoid exacerbating pre-existing inequalities. While health research has the potential to bring benefits to society and to the research communities, it can be associated with risks to the research participants. It is the obligation of any nurse researcher to protect participants by minimizing those risks and seeking approval of Institutional Ethics Committee (IEC). The rationale for requiring third-party review of research is that the participants are often asked to undertake risks that are not offset by any potential personal benefit, in order to develop scientific knowledge that may benefit others in the future.

IEC review is designed to ensure that the risks assumed by the participants are carefully examined and minimized to the extent that is reasonably possible, that the risks that remain are reasonable in relation to the potential benefits of the study, and that other ethical considerations, such as informed consent and confidentiality, are adequately addressed.
